
#### Getting to know our Community Partner...JU

### Leaving Assets to Your Loved One

With certain assets such as life insurance policies. retirement plans, and annuities and wills, you must designate beneficiaries and contingent beneficiaries. Although your first inclination might be to name your loved one with special needs outright as your beneficiary, such a designation could jeopardize his or her entitlement benefits. government Leaving assets in your will to a loved one that is receiving benefits like Medicaid or SSI could disqualify them from continuing to receive those benefits. An inheritance, a gift from a relative, or a personal injury award may also push your loved one's assets over the \$2000 limit mandate. One of the ways to avoid this and still ensure that your loved one still receives what you want to leave them is to open a special needs trust for your loved one and designating the trust as your beneficiary. This makes the assets available to your loved one as a beneficiary of the trust but the assets are not counted against them, slowing them to stay under the asset threshold and maintain benefits.
